Sealed bids are hereby invited from the reputed firms for Comprehensive Annual Maintenance Contract for Window A.C., Split A.C and voltage Stabilizers installed in the Ministry of Textiles, Udyog Bhavan, New Delhi, residence HMOT and Residence Offices of HMOST.

- 2. The interested parties may send their quotations alongwith earnest money deposit of Rs.20,000/- (Rupees twenty thousand only) in the form of demand draft drawn in favour of DDO, M/o Textiles. Bids without the earnest money deposit will not be considered. Bids complete in all respects may be addressed to The Section Officer(Admn), Ministry of Textiles, Room No.29-B, 'D' Wing, Ground floor, Udyog Bhawan, New Delhi and should reach this Ministry latest by 3.00 PM on 25th June, 2018. The bids will be opened on same date i.e. 25th June, 2018 at 3.15 PM. In Room No.29-B, Udyog Bhawan, New Delhi. The bidder or his authorized representative may be present at the time of opening of bids who may wish to attend.
- 3. The terms and conditions for the tender are as under and the tender should include the following:-
- a) The rates of comprehensive maintenance of Air conditioners shall include the gas filling, oiling, chemical washing, general services, switch, sockets, repair of compressors, repair/replacement of motor, repair/replacement of all minor and major parts except replacement of compressor, grill, pipes, removal, shifting and installation charges. No carriage charges for removal/return of machine from office to workshop and vice versa shall be paid by the Ministry.
- b) The firm must possess the requisite registration with the EPF/ESI/Work Contract/labour Contract/Income Tax and Allied Statutory Authorities.
- c) The Contractor must submit the following documents alongwith the quotation:
 - i) Registration with Delhi Sales Tax Ministries/Deptt. For work contract Tax.
 - ii) Proof of Income Tax Assessment.
 - iii) Documentary proof of 5 years experience and financial turnover of Rs.10 Lakh per annual.

- iv) Number of service Engineers and other staff employed and Govt. offices/private institutions/firms where the firm is working under AMC presently.
- v) Documentary proof of allotment of Service Tax No, EPF, ESI etc. by the concerned Government offices.
- d) The firm should have minimum experience of 3 years in maintenance of various types of Air Conditioners and other related works with yearly turnover of Rs.10 lakh or above. A list of clients should be enclosed along with the proper documentary proof. The bidder must submit certificates from at least three Ministries/Department/PSUs/reputed private institutions/firms to the effect that the firm has given satisfactory service/performance alongwith the bids without which bid is liable to be rejected.
- (e) The successful bidder will have to deposit **Performance Security Money for an amount of Rs.40,000/**-(Rupees forty thousand only) in the form of an Account Payee Demand Draft, Fixed Deposit Receipt from a commercial Bank, Bank Guarantee from a commercial Bank in an acceptable form safeguarding this Ministry's interest in all respects. Performance Security should remain valid for a period of **forty five (45) days** beyond the date of completion of all contractual obligation of the firm including warranty obligation. Bid security of the successful bidder will be refunded on receipt of performance security. The Performance Security Deposit will be forfeited if term and conditions of contract are not fulfilled.
- (f) MSME firm, Central purchasing organization or registered in concerned Ministry are exempted to submit earnest money Rs.20,000/-in the form of demand draft.
- g) This contract shall remain in force for one year unless terminated earlier by this Ministry on the basis of poor performance or violation of terms of the contract. The contract however, may be curtailed or extended by the competent authority in Ministry of Textiles subject to the performance of the firm.
- The contractor shall be responsible for maintenance of Window/ Split AC unit in working order by placing the services of experienced technicians/mechanics in this Ministry through-out all working days and they will be bound to carry out job of urgent nature even during odd hours and holidays, if so desired by the Ministry.
- No Air conditioner will be taken out by the Engineer to the workshop without prior approval of the Competent Authority in this Ministry. In that case, the firm will provide stand by arrangement without any extra cost and security cost of the machine.
- i) It shall be responsibility of the contractor to hand over all the air conditioners to the Ministry in working condition at the completion of the contract.
- k) It will be ensured by the firm that all the filters are cleaned regularly on a fortnightly basis and the air conditioner are kept defect free throughout the year. Failure to repair/service the equipment in question within 24 hours without justifiable reasons or to return the repaired machine within two days at the maximum may entitle proportionate

- If the work is found unsatisfactory or if the firm dishonors the contract, the job will be entrusted to any other firm/party at the risk/expense of the contractor.
- m) The Ministry reserves the right summarily to terminate the contract at any time without assigning any reason. In this connection, the decision of the Ministry shall be final and binding on the contractor.
- n) No advance payment will be made. Subject to satisfactory performance, payment will be made as under:
- o) No extra payment/compensation whatsoever, on account of natural calamity/accident or otherwise, will be made to the firm by the Ministry except the rates permitted under this contract.
- No advance payment will be made. However, quarterly payment on pro rata basis on satisfactory rendering of service would be made.
- a) All disputes will be subject to the jurisdiction of the New Delhi/Delhi courts.
- 4. This Ministry reserves the right to accept or reject any tender in full or in part without assigning any reason thereof.
- 5. All the parties are requested to read and understand the terms and conditions of the contract as detailed out in the foregoing paragraphs before sending their bids, as the bids will be considered and the contract will be finalized taking in to account the requisite documents received along with the tenders. Further, no change of violation of the aforesaid terms & conditions will be permissible once the quotation is finalized and accepted by this Ministry.
