### Monthly Summary to the Cabinet for the Month of March, 2022

1. Policy Decisions: Nil

### 2. Important Achievements:

- (i) Operational Guidelines for Product Linked Incentive (PLI) Scheme have been uploaded on the website of Ministry. Applications under PLI Scheme for Textiles are being received through web portal, which was initially opened from 01.01.2022 to 31.01.2022 and later extended upto 28.02.2022. A total Number of 67 applications have been received under PLI Scheme The applications received in the web portal are examined by PMA appointed by this Ministry for PLI Scheme. The first Selection Committee meeting under the Chairmanship of Secretary (Textiles) was held on 31.3.2022 to consider applications under PLI Scheme.
- (ii) During the month of March 2022, 1380 UIDs have been issued with a project cost of Rs. 8832.71 Crore along with subsidy requirement of Rs. 593.58 Crore under the Amended Technology Upgradation Fund Scheme (A-TUFS).
- (iii) All India arrival of seed cottons was around 42.70 lakh bales. Cumulative arrival of cotton between October 2021 to March 2022 has been 264.66 lakh bales. This is approx. 18% less as compared to corresponding period of last year. However, arrival this year is 0.25% lower as compared to average arrival during the corresponding period of last 10 years. Since the prices of cotton in market is ruling above MSP, Cotton Corporation of India (CCI) has not procured cotton under MSP operations during March, 2022.
- (iv) First instalments of Rs. 550 Lakhs and Rs. 60.75 Lakhs have been released towards sanctioned projects under Comprehensive Handicrafts Cluster Development Scheme (CHCDS) in Odisha and Ladakh respectively.
- (v) During the month of March, 2022 NIFT Campuses successfully organized 4
  events as per the themes identified for Azadi Ka Amrit Mahotsav.
- (vi) During the month of March 2022, Office of the Development Commissioner (Handlooms) has organized exclusive Handloom Expo "Jharokha: Celebrating Crafts of India" on the occasion of "Azadi ka Amrit mahotsav" through Weavers Service Centres at (i) urban Haat, Dimapur; (ii) Ahmedabad; (iii) Urban Haat, Ajmer; (iv) Coimbatore; and (v) Pune.

In March 2022, Under Weavers' Mudra Scheme, total 1547 MUDRA Loans were sanctioned.
