# Laundering case against Vaghela in ₹700cr 'scam’

New Delhi: The Enforcement Directorate(ED) registered on Wednesday a mo-ney-laundering case against ex-Union minister Shankarsinh Vaghela and some others in connection with the sale of a prime National Textile Corporation (NTC) plot in Mumbai, which reportedly caused a loss of Rs 709 crore to the exchequer.

The CBI had filed a corruption case in the matter last year. The ED took cognizance of the CBI FIR and registered a case under provisions of Prevention of Money Laundering Act (PMLA) after identifying the "proceeds of crime".

ED officials said Vaghela, aformer Gujarat CM, and others named in the FIR would soon be questioned. The case pertains to the sale of NTC land to a private Kolka-ta-based firm for a meagre Rs 29.35 crore when Vaghela was the textiles minister.

The CBI had alleged that the accused entered into a criminal conspiracy and transferred the land in a wrongful manner for Rs 29.35 crore, whereas its actual value was much higher.

It was alleged that during UPA term, Vaghela, who moved from BJP to Congress, had overruled re-

commendations of his ministry officials that NTC must make a detailed evaluation of the land before a nod for transferring it to the company was given. Besides Vaghela those named in the CBI FIR include the then chair-man-cum-managing director of NTC K Ramachandran Pillai, its then director (technical) R K Sharma, senior manager (legal) M K Khare and a Kolkata-based privatefirm and its director.

The property inquestion is part of the 80,785 square metre land of 'sick' Madhusudan Mills which was taken over by NTC.

## Cabinet clears new motor vehicle Bill

New Delhi: The government Wednesday approved the Motor Vehicle (Amendment) Bill 2016 that proposes hefty penalties for violation of traffic norms, including up to Rs 10,000 fine for drink driving and Rs 2 lakh compensation in hit-and-run cases.

The Bill also has provision of up to Rs 10 lakh compensation in case of road fatality.
"It is a historical step towards making our roads safe and saving lakhs of innocent lives," said Road Transport and Highways Minister Nitin Gadkari.

He said the Bill includes penalties in the range of Rs 1000-Rs 4000 for over-speeding.

As per the Bill, driving without insurance will be punishable with Rs 2,000 fine and/or threemonth imprisonment, while driving without helmets will attract Rs 2,000 fine and 3-month suspension of licence. The provisions also include that guardian/owner will be deemed to be guilty in case of road offence by juveniles. PTI

NEW DELHI: While farmers in parts of Punjab have started uprooting cotton crop fearing whitefly pest attack, officials from the State government and the Centre are touring the cotton-belt to monitor the situation.
The pest attack, which caused extensive damage to Bt cotton crop last year in Punjab and neighbouring Haryana, had been reported this year as well in a few villages of Malwa region, mainly Fazilka district of Punjab.

Farmers are worried that there could be increased infestation if the current hot and humid weather conditions continue to prevail for the next 15-20 days. An increase in jassid pest attack, which too sucks the crop like the whitefly, is worrying farmers in parts of Mansa and Bathinda

## districts.

After facing farmers' wrath in the poll-bound State last year, the ruling Akali government and the Centre are taking no chances. The team of officials and experts touring the cotton belt for surveillance will hold a review meeting on August 3 .
"We have been able to control the spread this season, as it is limited to 132 acres in a few villages... But the next 20 days or so are critical. If it rains it will be good for the crop. Whitefly pest grows and spreads in dry, hot and humid conditions," Jasbir Singh Bains, Director, Punjab Agriculture Department, told The Hindu. Mr. Bains is a part of the expert team.
Mr. Bains disagreed that farmers were uprooting cotton crop due to whitefly pest. "It's the late sown cotton crop that farmers have uprooted in
a few villages, to replace it with paddy to ensure better returns," he said.
Whitefly attack caused extensive damage to Bt cotton varieties last year in Punjab and Haryana, resulting in a drop of nearly 40 per cent in production. Bt cotton accounted for over 98 per cent of the total cotton sown last year in both the States. The remaining two per cent was the indigenous cotton varieties. This season too, Bt cotton accounts for over 93 per cent of the total cotton sown.
After the losses they suffered last year due to whitefly attack, farmers in both Punjab and Haryana have planted less cotton this year. In Punjab, the area has shrunk to 2.56 lakh hectares, against 4.50 lakh hectares last season. In Haryana, cotton has been sown in 5 lakh hectares this year, against 5.80 lakh hectares last year.

## Vibrant textile traditions thrive in Northeast

is handloom week and, for a diehard handoom fan like me, pleasure to see the lead taken by the textile minister, Smriti Irani, to take forward the struggle to make handlooms the first choice for apparel espepeople And the younger to turn the spotlight on the role played by women in the entire weaving process is really noteworthy, After all, women play a pivotal role in the process of weaving and spinning and in some areas like the Northeast and many other places it is women who do most of the weaving and keep the tradition alive.
Perhaps least known in other parts of the country are the vibrant and exquisite textile traditions of the Northeast. I have shared some really joyful mavels in the extensive Nravelheast ine interiors of Assam with women weavers who went about creating saris, mekhla chadors as they sat under almost ramshackle thatched roofs with their rather basic looms weaving the most intricate dreams so joyfully, laughing, singing and cracking jokes. It is so ironical that so many of them wouldn't even have chance to wear some of the fabulous tex tiles they helped create. Even in the middle ages, the ancient Ahom (present day Assam) kings, like the nobilities of Japan, patronised sing rearing and silk on the part of certain on the part of certain reel the yarns and practice weaving almost as a household activity Mulberry silk was exclusively reserved for royalty, the muga for nobleman and the eri for commons possibly because of the textures, purity of silk and lifestyles. It is in interesting that now it is muga that is considered to be the veritable king of silks by the region, followed by pat and eri. Specific ing set apart the tribes with a complex hierarchy firmly in place even till date especially at the
grass-root level.
In the women's market in Imphal, Manipur, which is in full swing at the crack of dawn, women from many parts of the hills and, of course, the valley have reserved spaces where they bring the vibrant phaneks lungi-like apparel worn and further embellished by intricate embroidery on them to sell. It is inter. esting that these phanek designs are peculiar to each tribe and they wear specific designs only. There were some with neutral "temple" designs that could be sported by anyone. Till date, I regret not buying an exquisite silk phanek in emerald green with brick red temples and matching chador that a woman weaver was selling in that market. The colour and texture of the fabric is still vivid in my memory even after two visits I made it a point to visits I made it a point to found anything breathtaking
In Nagalan
exclusively wool almost ton is woven in small portable looms and since only narrow pieces can be woven on it, they are joined together. Incidentally, similar is the case in Manipur and other parts of the Northeast where the loin loom is in use. Naga tribes weave their specific sashes, shawls and other textiles, with designs peculiar to each thite and All those red, shawls that look same if not similar to the uninitiated have their own story to tell of tribes and their lifestyles and heroes. It is an entire language in itself.
In Arunachal Pradesh too, there has not been much external influence on the designs of the textiles although there has been some borrowing of motifs from neighbouring areas. The motifs, designs and patterns, however, are gymbolic cox and their usages are and significant

that any man who touches dye or a cloth that is being dyed will be unable to shoot any game and will be especially liable to suf. fer from consumption.
The reason why particis pation in dyeing results in bad luck in the chase is rather complicated. Animals are terrified of blood, and consequently are very afraid of the women due to menstrua cycles. The hands of man who takes part if dying are strained with the blue dye and the smell of the dye hangs about them. The souls of the wild animals when such once, and wpproaches they associat him in their minds with women frightened, and refuse to allow him to approach
them. Hence, a man who helps his wife to dye cloth is always unlucky in the chase.
In Tpipura, till as late as the 19th century, every family had a loom, irre spective of caste or com munity. An ancient king named Trilochan (alias Subrai) was a great patron and he married many girls only to honour their skills Cotton would be abundant ly produced in the Jhoom fields in the hills. The main feature of Tripura handlooms is ver tical and horizonta embroidery in differen embroidery and designs tribe peculiar. The Khakloo are a small, little known tribe who claim direct relationship with the Purum Tipra - a dom inant community that ruled Tripura for cen turies. The cotton is grown in the jhoom. Women do spinning and weaving only. It is forbidden for men to take any part in the operation, as it is reared that any man who particiing will be struck by lightning. Similarly, there is a ning. Similarry, there is making it is believed that if any woman weaves basket, the male will be idle and timid and, as a result, he will not be suc cessful in hunting.
The clothes the KukiChin tribe women from Tripura wove in the past had designs that were copied from the skins of snakes. They were called by different names like Thangang, Saipi-khup Ponmongvom, Khamtang. These clothes in the olden days were not allowed to be woven by the chief's and the official's families were allowed to weave these clothes. It was also forbidden to put on these clothes while cross ing a big river. It was feared that the cloth might attract snakes to the weavers. Many of these beliefs might seem quaint but this is a living reality with the weaving commu nities there and taken rather seriously. I was warned by my focal trave companions to ne
speak about it in jest.

CBI had alleged that the accused entered into a criminal conspiracy and transferred the land in a wrongful manner, for a total consideration of ₹29.35 crore (approx), whereas its actual value was much higher, causing an alleged loss of about ₹709.27 crore to the Government exchequer.

जागरण ब्यूरो, नई दिल्ली: एक देश, एक टैक्स का सपना अब हकीकत बनने जा रहा है। दशक भर से अधिक के इंतजार के बाद आखिरकार राज्यसभा से जीएसटी लागू करने को आवश्यक संविधान संशोधन विधेयक पारित हो 'ग्रया। राज्यसभा में मौजूद 203 सदस्यों ने इसंके समर्थन में वोट किया। माहौल कुछऐसा बना कि विरोध में खड़े अन्नाद्रमक ने भी औपचारिक विरोध से बचते हुए वाकआउट कर विधेयक पारित कराने की राह आसान की। अब इस विधेयक को कानून बनने के लोकसभा के साथ 29 में कम से कम आधे राज्यों की विधानसभाओं की मंजूरी की जरूरत होगी।

राज्यसभा में बुधवार को इस विधेयक पर करीब आठ घंटे तक चली चर्चा में कंग्रेस समेत तमाम विपक्षी दलों ने जीएसटी की अधिकतम दर 18 फीसद रखने की वकालत की ताकि आम जनता की जेब पर अधिक बोझ न पड़े। वित्त मंत्री अरुण जेटली ने चर्चा के जवाब में स्वीकार किया कि टैक्स की दर नीची रहनी चाहिए और केंद्र सरकार यह सुनिश्चित करने का प्रयास करेगी कि राज्यों के साथ एक उचित दर पर सहमति बने। उन्होंने स्पष्ट कर दिया कि टैक्स की दर तय करने का काम जीएसटी काउंसिल को करना है जिसमें राज्यों के साथसाथ केंद्र की भी हिस्सेदारि होगी। इस काउंसिल में सभी राज्यों और सभी राजनीतिक दलों के प्रतिनिधि होंगे, लिहाजा कोई आवश्यकता से अधिक ऊंची दर रखकर जनता की नाराजगी मोल नहीं लेना चाहेगा।

काउंसिल में विवाद की स्थिति में दो-तिहाई भार राज्यों के पास होगा और एक तिहाई केंद्र के पास रहेगा। साथ ही वोटिंग के वक्त काउंसिल के सदस्यों की कुल संख्या का तीन चौथाई उपस्थित होना आवश्यक होगा। जेटली ने कहा कि यह व्यवस्था इसीलिए बनाई गई है ताकि केंद्र या राज्यों पर मनमानी का आरेप नलगे।

## पांच साल तक राजख की क्षतिपूर्ति

राज्यसभा में जिन महत्वपूर्ण बदलावों को जीएसटी से संबंधित संविधान संशोधन कानून का हिस्सा बनाया गया है, उनमें जीएसटी लागू होने पर राज्यों को होने वाली राजस्व हानि की पांच साल तक भरपाई सुलिश्चित करने के वैधानिक्रावधान शामिल हैं। इससे पहले तीन साल तक शत-प्रतिशत भरपाई का प्रस्ताव किया गया था। दूसरे, सरकार ने राज्यसभा में रखे विधेयक में मैन्यूफैक्वरिंग करने वाले राज्यों को एक फीसदी अतिरिक्त कर की दर का प्रस्ताव भी वापस ले लिया है। जीएसटी लाने का एलान सबसे पहले साल 2006-07 के आम बजट में हुआ था। उस वक्त इसे पहली अप्रैल, 2010 से लागू करने का लक्ष्य तय हुआ था। सरकार ने फिलहाल इसे एक अप्रैल, 2017 से लागू करने का लक्ष्य रखा है। जीएसटी लागू होने के बाद केंद्र और राज्यों के करीब डेढ़ दर्जन परोक्ष कर समाप्तहो जाएंगे।

# Etailers Out of Cash, Out of Fashion 

## Portals like Freecultr, Zovi and Fashionara on verge of closure; environment tougher with ecomm giants focusing on the space

New Delhi: Despite fashion being a key growth driver for online retai in India, some e-commerce ventu res in this category find themselves on a sticky wicket.
Unsuccessful attempts to raise money or find buyers is forcing some of these portals, which had resorted to deep discounting to lure customers but are now confronted with a cash crunch, to close or scale back their operations.
Sequoia Capital-funded ecommer ce company Freecultr, which was in talks with Arvind Group for a pos sible sell-off, has shut down its website, say two people familiar with the development
Sandeep Singh, cofounder of Free cultr, that sells own brands of fas hion and lifestyle products, said the website is currently not operational because there is a "technical error"
"We are in a transition and a team is looking into it," he said. Singh declined to comment on why the e-commerce remained shut for days altogether. "I can't comment on shutdown," he added.
Currently, Freecultr's website does not even appear in a Google search The company last updated its Face book page in March and Twitter timeline on April5.

Manish Chopra, CEO of Zovi, denied any plans of shutting the por-
tal. "At present we arenot selling directly via the portal but we are selling through our marketplace partners," he said citing shifting of warehouse from Delhi to Bengaluruas the reason.
Working closely with marketplaces like Amazon and Flipkart has always been important part of the company strategy and will remain so, he added. Zovi's last update on its social media accounts - Facebook and Twitter - was in May informing buyers about the ongoing sale for men's t-shirts.
Online marketplaces like Amazon and Flipkart are looking at fashion and lifestyle as growth drivers and companies with deep pockets such as Aditya Birla Group, Tata Group, Arvind and Reliance Retail are jumping on the band wagon.
Last month, Flipkart-ownedMyntra acquired Jabong to consolidate its position in this segment, although the price it paid was a fraction of what the owners of Jabong were originally expecting.
The online fashion segment is currently estimated at $\$ 2$ billion and is estimated to swell to $\$ 20$ billion by 2020, surpassing consumer electronics as the single largest on-

## line category.

But the going is getting tougher for smaller online fashion retailers amid drying up of funding options.

Fashionara, an online retailing venture focussed on fashion and lifestyle, folded up few months ago after struggling amid dwindling business and cash crunch. It was backed by Lightspeed Venture Partners and Helion Venture Partners. Its founder Arun Sirdeshmukh has joined Amazon as the head of its fashion portfolio. Older fashion ecommerce portals, like FashionandYou.com are struggling with fund raising options.
"Yes you areright, new fundingrounds have been a challenge for all players in the space and Fashion and You is no exception," said Harish Bahl, CEO of Smile Group which is a minority shareholder in the company. Bahl added that he was not the official spokesperson of the company, whose major shareholders include Sequoia Capital and Norwest.
It has closed some of its large warehouses in the last few months, including the one in Gujarat, according to people familiar with the company. Bahl, said that the warehouse closed as the company has moved to a marketplace model.

# New hope for man-made textile segment as GST regime likely to 'erase' disparity in duty rates

New Delhi, Aug 3

AS THE country braces for a goods and services tax (GST) regime, the man-made textile segment, long neglected by policy makers, finally expects a "level-playing field" vis-a-vis cotton textiles.

At present, while man-made fibres attract a $12 \%$ excise duty, cotton fibres attract none. This duty disparity has distorted the domestic consumption pattern in favour of the cotton fibre, contrary to the globaltrend.

Although the actual GST rate applicable totextile and garment products will be announcedinduecourse, seniortextileindustry executives say the current disparity in the excise duty rates of cotton and man-made fibre will be "erased", unless the government decides to give some exemption to cotton fibres. Industry executives expect a GST rate of around $15 \%$, if the peak rate is $18 \%$, arguing that textile

and garments are essential items.
"Man-made fibre-based products will be more competitive vis-a-vis textiles items based on cotton fibre. This will be a good policy push, in sync with the global realities," said noted textile expert DK Nair, who is also an adviser to South Indian Textile Mills Association. However, both cotton and man-made fibre are also subject to $4-5 \%$ state VAT, which will be subsumed by the GST.

However, if theduty treatmentof allcotton and man-made fibres remains the
same,pricesof textileitemsmadeof cotton fibrecouldriseatad,Nairadded.Butequal tax treatmentwillgiveapushtoman-made fibreproduction and subsequentexports.

The industry has long been complaining that the duty disparity is preventing domestic producers from scaling up operations and, consequently, hurting India's export competitiveness in man-made textiles. This is because while man-made fibresaccountforaround $70 \%$ of the world's total fibre consumption, they make upfor less than $30 \%$ of India's demand.

The government in June announced radicalchangestolabourlaws, apartfrom some concessions to the garments sector, aimed at boosting exports of textiles and garmentsby $\$ 30$ billionover thenextthree yearsfrom $\$ 40$ billion in 2015-16. Lastyear, the textile ministry had recommended a reduction in the excise duty for the manmadetextilesector to6\% from the current $12 \%$. However, such a step was never approved by the government.

## Farmers cotton on to new seed, in blow to Monsanto

New Delhi/Mumbai, Aug 3: In atiny hamletat theheart of the cotton belt in northern India, Ramandeep Mann planted Monsanto's genetically modified Bt cotton seed for over a decade, but that changed after a whitefly blightlast year.

Mann's 25-acre farm in Punjab's Bhatinda district now boasts "desi", or indigenous, cotton shrubs that promise good yields and pest resistance at a fraction of the cost.

Mann is not alone
Thousands of cottonfarm ers across the north of India the world's biggest producer and second largest exporter of the fibre, have switched to the new local variety, spelling trouble for seed giant Mon santo in its most important cotton market outside the

Americas.
The Indian government is actively promoting the new homegrown seeds, having already capped prices and royalties that the world's largest seed company is able to charge.
"Despite the whitefly attack, farmers in northern India are still interested in coton, but they are moving to the desi (indigenous) variety" says textile commissioner Kavita Gupta

Official estimates peg the area planted with the new variety at 72,280 hectares in north India, up from roughly 3,000 hectares lastyear.

That is still a tiny percentageoverall,andmostfarmers in the key producing states of GujaratandMaharashtraare sticking to Monsanto's GM cotton, which has been in-

strumental in making Indiaa cotton powerhouse.

And the impact of whitefly, a pest that thrives in dry weather, may not be as big this year, as monsoon rains are likely to be plentiful. Experts said two straight droughts fanned last year's infestation.
But the new seed is still a setback for Monsanto, which

National Seed Association of India.
The firm, which last year sold some 41 million packets of Bt seeds in India, could stand to lose up to $₹ 5$ billion ( $\$ 75$ million) due to lower sales and the steep cut in royalties enforced by the government earlier in 2016, according to Reuters calculations.

The company, which unsuccessfully challenged India's decision to slash royalties in the courts, declined to comment for this article.
But in the wake of the whitefly infestation, Mahyco

MonsantoBiotech(India)Pvt Ltd (MMB), a joint venture withIndia'sMahyco, saidlast yearthatMonsantoanditsIndianlicenseesmarketed their product as resistant to bollworms, not other pests.

Some experts were opti mistic the indigenous cotton seeds developed by the Cen tral Institute for Cotton Research (CICR), which comes under the farm ministry would catch on over time.
"Just wait for the crucial three to four years to see a complete, natural turn around. By then most farm
ers will give up Bt cotton and go for the indigenous variety," saidKeshav RajKranthi, head of CICR.

Kranthi said planting a hectare with the Indian variety cost less than half the ₹ 80,000 farmers paid to sow Bt cotton over the same area, and the crop yield was almost as high.

Unlike GM seeds, farmers could also store and replant the local seeds the following year, he added
some experts voiced caution over the new variety, however. "Byallaccounts, the indigenous cotton looks prettypromising, butitwill beput to test this year," said Devinder Sharma, an independent food and trade policy analyst. "It's a potential game changer but it has to succeed first."
