CROPAREA REINED IN 9%

A DELAY in the arrival of the monsoon and dragged down the sowing of summer crops by almost 9% until Friday from a year before, the latest farm ministry data showed, reports **fe Bureau** in **New Delhi**. Although the water storage level across 91 reservoirs in India has been the same as last year level (at 26% of the total storage capacity), partly aided by unseasonal showers in northern and central India earlier this year, sowing operation would be affected in coming weeks if the geographical spread of rainfall remains patchy on top of a deficient monsoon, as predicted by the Met department.

Area under paddy went up 4.2% until Friday from a year earlier, while that of oilseeds, too, has gone up in the initial stage of planting (*see charts*). However, the coverage of coarse cereals was hit the worst, having plunged by almost 60% from a year earlier, and the planting of pulses declined nearly 11% until Friday.

favourable base, as in 2014-15, too, planting was initially affected by dry spells and the monsoon hit the Kerala coast only on June 6, a day later than this year.

Although water reserves are at the last year's level, according to the data from the ministry of water resources, states having lower storage thanthecorrespondingperiod of last year are Rajasthan, Jharkhand, West Bengal, Gujarat, Maharashtra, Uttar Pradesh, Madhya Pradesh, Chhattisgarh, Andhra Pradeshand Telangana, many parts of which were expected to face dry spells for a second straight year. Earlier, official sources had said pulses, coarse cereals and oilseed crops could be affected because states in the northwestern and central regions are among the largest producers of these items.

The country imports more than half of its edible oil and one-fifth of its pulse requirements annually and any drop in the production of commodities further enhances reliance on imports. Luckily for the government, global prices of most of the commodities, includingedible oils, are already depressed, which has reduced therisks of imported inflation significantly. Food minister Ram Vilas Paswan has also asked authorities to undertake massive anti-hoarding operations to ensure smooth supplies of items such as pulses. Summer crops are usually sown with the arrival of the monsoon rains in June and harvested from mid-Septemher

The quantum of rainfall during June 1-11 (40.8 millimetres) has trailed the benchmark 50-year average by just 1% despite the delay in the monsoon onset over Kerala thanks to pre-monsoon showers. The India Meteorological Department(IMD)this month revised downward its forecast of seasonal showers for this

year to 88% of a long-period av-2 erage(LPA)-the same as last r vear - from its April prediction of 93%. Private weather forecaster Skymet, however, · has predicted a normal monsoon, with showers at 102% of the LPA.

After a delay of a couple of days, the southwest monsoon crossed the Mumbai coast on Friday According to Skymet, the monsoon has already covĩ ered Kerala, Tamil Nadu parts of Karnataka and the entire northeast India. However it said that monsoon "continues to be delayed, and a little weak as the cyclonic storm in the Arabian Sea has drifted towardsOman coast, pulling the moisture from the region, which will take some time to replenish". But it added that there were chances of good widespread rain across the country from June 13 due to multiple weather systems. "This could be construed as precursor to monsoon onset over some parts of the country," it said.

Chief Minister K Chandrasekhara Rao tried to strike a chord with the industry by assuring them of a "graft-free, hassle-free" system that gives no scope for "pairavees" (lobbies).

He promised them a red carpet welcome to the CM's Office from the airport and to vet their applications as quickly as possible. "We are going to penalise officials ₹1,000 a day for delays," he said.





Kharif sowing down 8.7% on monsoon delay

SANJEEB MUKHERJEE New Delhi, 12 June

Delayed arrival of the monsoon, along with its uncertain run so far over much of central and northern parts of the country has disturbed the sowing of kharif crops, mainly coarse cereals and cotton.

Sowing of kharif crops as on June 12, is almost 8.71 per cent less than the same period last year at 7.51 million hectares, with the maximum impact on coarse cereals and cotton, mainly grown in Maharashtra, Gujarat and Bihar.

In total, kharif crops are sown on 105.06 million during hectares the Data from season. the Department of Agriculture show paddy has been planted on 0.47 million hectares, up from 0.45 million hectares planted in the year-ago period.

Pulses have been sown on 0.24 million hectares, down from 0.27 million hectares. In total, the crop is planted on 10.81 million hectares.

Officials said a strong push to sowing of kharif crops will come if monsoon reaches central and northern parts of the country on time, which is expected to be around end of June. India Meteorological Department (IMD) said on

Thursday the country received 36.4 millimeters of rainfall between June 1 and 10, which is almost near the normal of 36.2 millimeters.

However, monsoon in the northwest parts of the country - which includes the key grain-producing states of Punjab, Haryana, Uttar

Pradesh and Rajasthan - has been around 13 per cent below normal in the first 10 days. In Central India, which comprises Madhya Pradesh. Gujarat and Maharashtra, it has been 31 per cent below normal.

The Met department said that in the week ended June 10, rainfall intensity went down slightly and showers were around five per cent below normal, mainly due to Cyclone Ashobaa.

AccuWeather senior meteorologist Jason Nicholls said though monsoon has arrived, drought would be a problem across much of the country and in Pakistan this season.

"A developing El Niño is expected to lead to belownormal rainfall across much of India this monsoon season with northwestern India and Pakistan likely the driest,' said Nicholls.

Far southern and northeastern India might be the only areas to reach normal rainfall totals during the 2015 monsoon season, he added. The southwest monsoon

reached Mumbai on Friday. Regular rainfall was expected only in four or five days, Mumbai Regional Meteorological Centre's director-general V K Rajeev told PTI.



Western adventures in Chinese design



oco Chanel, Christian Dior, Yves Saint Laurent, Ralph Lauren, Jean Paul Gaultier, Alexander McQueen, John Galliano, Tom Ford, they all fell under the spell of China. In fact, name any major Western designer

over the last 100 years, and almost like a rite of passage, they have all turned to China for inspiration, and created fantastical dresses that marry Chinese aesthetics with Western form. These dresses, juxtaposed alongside the original inspiration-whether it is imperial Qing dynasty robes, delicate blue porcelain vases, ancient calligraphy, sultry Shanghainese actresses from the 1930s, or even the no-frills Mao uniform-form a fascinating exhibition called *China*: Through The Looking Glass, currently running at the Metropolitan Museum of Art. New York.

To see inspiration and end product side by side is a visual delight, sometimes so beautiful it leaves you emotionally stunned. Take for instance the robe of the Oianlong Emperor (1735-95) in yellow silk satin, intensely embroidered with writhing dragons, curly-wurly clouds, elongated pagoda, multicoloured candy stripes—an exquisite piece of history that you admire. And then you turn to the sequined dazzler of a dress next to it and you gasp-this is Tom Ford's take on the emperor's old clothes, created for Yves Saint Laurent's autumn/winter 2004-05 collection. The loosely cut robe has been turned into a figure-hugging evening gown, every inch of it twinkling with sequins-it is still yellow, the dragon, the pagoda, the clouds, the candy stripes are all there, but now the

garment oozes oomph and 21st century glamour. This is design sorcery.

This abiding love affair with China is intriguing. What is it that draws Western designers in such vast numbers to this faraway land? What is the special pull of Chinese culture that fires their imagination? What spurs them to adapt and adopt a set of symbols so alien from their own? Clearly China's rich and colourful sartorial history-as exemplified by the sumptuous imperial robe above-plays a role; but there is more, an elusive mix of elements that beckon and grip these designers' collective fantasy.

There are many possible answers, but definitely the fantasy of China as portrayed in the movies is a strong force. The American-Chinese actor Anna May Wong, who played stereotypical roles in Hollywood movies in the 1930s-sometimes a wily "dragon lady", sometimes a docile "lotus flower"-was one of the first to shape the Western mind. The stunning black charmeuse evening gown she wore in the 1934 film Limehouse Blues is on display here-designed by American designer Travis Banton, it has a massive gold-and-silver dragon slithering up the entire front of the dress.

While Anna May Wong's sensualbut-somewhat-clichéd image is crafted by Western film-makers, the spate of films that came from Chinese directors like Zhang Yimou, Wong Kar-Wai, Ang

Lee in the 1990s and 2000s has created a more nuanced picture of Chinese femininity. My all-time favourite is Maggie Cheung in Wong Kar-Wai's 2000 film In The Mood For Love-there is a fleeting quality that she exudes, a fragility, a stillness, an indefinable yearning, and above all, enormous restraint, and yet, the sum total of all this is enormous sensuality. A fully clothed Maggie Cheung—in a series of gorgeous *qipao's*, I might addmerely standing by a window or walking down a shabby staircase packs more sensuality than the blatant, scantily clad come-hither sexuality portrayed in Western films. Perhaps it is this enigmatic sensuality that fascinates Western designers? Several outfits in the

exhibition embody this same quality. Jean Paul Gaultier's black satin dress from his 2001-02 haute couture collection is a splendid example-it is a highcollared, short-sleeved qipao, much like Maggie Cheung's, but there is a fantastical "garden" of black flowers and butterflies that adorns a daringly plunging nearnude tulle back. John Galliano's sheath-like *qipao*-dress in red silk jacquard is another example-from his autumn/winter 1997-98

collection for the House of Dior-it envelops the body like a second skin, heightening the awareness of every curve, so unforgiving in its cut that only a woman with a perfect figure would dare to wear it.

While one can understand the appeal of the sensual qipao, Western designers have had a field day with the figure of Mao, and played with the sheer drabness of the Mao suit. Chinese-American designer Vivienne Tam's dress from her 1995 spring/summer collection has Mao's

face repeated as a pattern all over the outfit-the face

treatment is reminiscent of Andy Warhol's prints, but taken a step further by the artist Zhang Hongtu who gives Mao a variety of props—sunglasses. bushy pigtails, squint eves focused on a blackened nose. While Tam pokes fun, John Galliano's jacket-andskirt ensemble for the House of Dior, spring/summer 1999, raises the plebeian Mao suit to a sophisticated style statement-the shapeless Mao jacket is given a tucked-in Dior waist, rendered in shantung, red silk piping, Chinese collar with military stars. It sits on a Mao-green skirt of

> pleated silk jacquard. Some of the most creative outfits in the

exhibition are inspired by blue-andwhite porcelain. Invented in Jingdezhen in the 13th century, fine works of porcelain are prized as priceless art. A 15th century jar with dragon designs seems to be the inspiration for Roberto Cavalli's magnificent evening dress-in blue-and-white silk satin-from his autumn/winter 2005-06 collection. Karl Lagerfeld honours the genre with an exquisite blue-and-white beaded dress with floral motifs for the House of Chanel's spring/summer 1984 haute couture collection. Sarah Burton takes a creative leap—she embroiders shards of blue-and-white porcelain on to fabric to build the bodice of her dress for Alexander McQueen autumn/winter 2011-12, while lush layers of white organza frills make up the skirt and extensive train. Chinese artist Li Xiaofeng gives up on fabric altogether, using pieces of broken porcelain to create a dress-like artwork titled Weight of the Millenium. As China's stature rises on the world stage today, this exhibition serves to remind that its history is extremely rich, and its hypnotic allure has always drawn adventurers. These designers are ultimately adventurers of the artistic kind, and China for them is a creative engine, where they seek and find endless stimuli.
