CBI registers FIR against Vaghela in NTC land scam



A team of 12 officials from Central Bureau of Investigation on Wednesday conducted search operation at former Cabinet Minister for Textile Shankersinh Vaghela in Congress-led UPA Government in connection with alleged ₹1,700 crore National Textile Corporation (NTC) land deal scam in Mumbai.

According to sources, the search operation was initiated from early morning at Vaghela's palatial residence 'Vasant Vagado' situated in Vasania village on the outskirts of Gandinagar. The search operation continued for nearly nine hours till 4 pm. Vaghela also signed a document after the completion of the CBI search operation.

Simultaneously, an FIR was also registered against the former Gujarat Chief Minister and current Leader of Opposition in the State Assembly, ex-chairman & Managing Director of NTC Ramchandran Pillai and five others for dubious sale of NTC land in Mumbai, which allegedly caused several hundred crores loss to the Exchequer.

Apart from Vaghela's residence in Gandhinagar, search operations were conducted at eight locations in three other

cities, including New Delhi, Mumbai and Kolkata. The CBI officials have reportedly have seized documents related to the scam from these locations.

Meanwhile, after the search operation, Vaghela hurriedly convened a Press conference and claimed that it was nothing but to divert the attention of public from the ongoing controversy of former IPL chief Lalit Modi, in which two top BJP leaders, including Union Minister Sushma Swaraj and Rajasthan Chief Minister Vasundhara Rajes names are also involved.

"CBI official were cooperated by me and my family members. They searched for long hours. All they found was a letterhead and visiting card of the time when I was union Minister. I have developed a habit of keeping my old visiting cards. "Even I have kept visiting cards printed in 1977. The officials were allowed to open my cupboards. They checked two houses of my sons," he said.

According to him NTC scam was deliberately flashed from Delhi keeping political vendetta as it is seven year old matter but they (NDA government) raised the issue when the central government is in trouble over the issue of Lalit Modi.

"People were carrying away bricks of dilapidated compound walls of closed NTC mills. We were paying security charges. The decision was taken to lessen the financial burden on the PSU. The land deal was transparent and we completed all the formalities," he said, claiming that as per his information at one point of time the NDA government was to sell all NTC lands in Mumbai for ₹200 crore. He said NTC had ₹1,800 crore debt but because of the efforts of the previous Government it earned ₹2,000 crore through NTC deals. He said right from Gandhinagar to Delhi all have burned fingers in corruption.

Ex-Union minister Vaghela booked in Mumbai land scam

NEW DELHI/AHMEDABAD: The Central Bureau of Investigation (CBI) has registered a case of alleged fraud and criminal conspiracy against former Union textile minister Shankarsinh Vaghela and five others, including a former chairman-cum-managing director of the National Textile Corporation (NTC).

The six accused sold around 27,585 square metres of a Mumbai textile mill's land to a Kolkatabased private firm for ₹29.35 crore for development in July 2009, termed as a deal 'for peanuts'. This led to an alleged loss of ₹709.27 crore to the state exchequer.

A CBI source said, "The then Union textile minister played a role in the irregularities. When the modalities for the sale of the mill's land were being worked out in the ministry, Vaghela had shot down the proposal of the then senior NTC officials that advocated a proper valuation of the worth of the property as per then market rates."

Vaghela, a former chief minister and now the Leader of Opposition in the Gujarat Assembly, denied the accusations. "It's nothing but veridetta politics and a cheap attempt to divert attention from the ongoing controversy involving Lalit Modi, Sushma Swaraj and Vasundhara Raje. The CBI has become a BJP Bureau of Investigation," he said. In a raid conducted earlier at his Ahmedabad home, ₹13.33 lakh was recovered from the premises.

CBI books former Guj CM Vaghela in NTC land scam

New Delhi: Digging out another UPA-era scam, the CBI on Wednesday registered a case against former Union minister for textiles Shankersinh Vaghela, former CMD of National Textiles Corporation K Ramachandran Pillai and private company Hall & Anderson Ltd and its director Kamlesh Mehta in the alleged sale of prime land belonging to Shree Madhusudan Mills in Mumbai at "throwaway prices".

The agency raided the former Gujarat CM's residence in Gandhinagar and recovered Rs 13.33 lakh cash and now plans to interrogate him.

The sale of governmentowned land to the private company at a price of Rs 29.35 crores



led to a loss of Rs 709.27 crore to the exchequer, as the market value of the prime pre-independence era property in Mumbai's Worli was much higher.

The scandal was first exclusively reported by **TOI** in May last year when CBI began a preliminary enquiry into the sale of Madhusudan Mills. Sources said that more such sales of mills owned by state-run NTC are under CBI scanner.

"M/s Madhusudan Mills

was taken over by the ministry of textiles/NTC and nationalized under the Textiles Undertakings (Taking Over of Management) Act 1983 and the Textiles Undertaking (Nationalisation) Act, 1995. All the assets of the said firm (Madhusudan) were transferred to the central government/NTC and suitable amount was paid to M/s Madhusudan," CBI says about the government taking over the Madhusudan Mills, which was listed among sick companies and was not operational.

CBI officials said Kamlesh Mehta of Hall & Anderson was allowed to develop 27,500 sq m of the 80,785 sqm area of Madhusudan Mill as part of revival of mills of NTC. The land was handed over at a price of Rs 29.35 crore to the Kolkatabased firm and its owner for redeveloping it in a move to reach a settlement in July 2009.

"It is alleged in the process of settling of issues regarding taking over of assets and liabilities of the Madhusudan Mills, Vaghela overruled the opinion of senior officers of the textiles ministry seeking a comprehensive proposal from NTC, owning the land, including the actual valuation of the land for settlement of the issues," says CBI FIR. "Vaghela overruled this view of ministry officials due to which valuation of property was not done," said a CBI official. CBI says Vaghela abused his official position to approve the sharing of the land in the ratio of 65:35 in favour of Mehta and his company.


CBI Files FIR Against Vaghela

New Delhi: The Central Bureau of Investigation (CBI) registered an FIR against Shankarsinh Vaghela and others including the then Managing Director of National Textile Corporation (NTC) for sale of prime property in Mumbai allegedly at "throwaway prices". Vaghela is the Leader of Opposition in Gujarat Assembly.

CBI said FIR has been registered against Vaghela, former NTC CMD Ramachandran Pillai, R K Sharma then director and M K Khare, then senior manager for allegedly causing loss of ₹709 crore to the exchequer through the sale of NTC land in Parel. The agency in its FIR alleged that Vaghela overruled the decision of NTC officials and gave favours to a private firm.

Soon after registering the FIR. CBI carried out searches at nine locations in four cities - New Delhi, Gandhinagar, Mumbai and Kolkata-including the residence of Vaghela and others. During raids, the agency seized a fixed deposit receipt of ₹1.65 crores and details of bank locker from the premises of Pillai while₹13.33 lakh cash were seized from Vaghela residence. Beside this, the agency also claimed to have found 2 bank locker and FD of ₹35 lakhs during the raids at the house of Sharma and Khare respectively.

CBI searches Vaghela's house over NTC scam

'Centre trying to divert attention'

Gandhinagar, June 17 The CBI on Wednesday registered a case against former Union Textiles Minister Shankarsinh Vaghela and five others for selling over 27,000 sq m of prime National Textile Corporation (NTC) property in Mumbai to a private company, allegedly at "throwaway prices" during the UPA-1 regime, causing a loss of over ₹700 crore to the Exchequer.

The CBI also raided the residences of Vaghela and the other accused. The former Gujarat Chief Minister claimed the raid was aimed at diverting attention from the Sushma Swaraj-Lalit Modi-Vasundhara Raje controversy. Vaghela, who once mentored Prime Minister Narendra Modi, had subsequently joined the Congress. At present, he is the Leader of Opposition in the Gujarat Assembly. Reacting to the CBI raids that lasted about 10 hours, Vaghela

told reporters here the Central

agency had found "nothing" and that he "fully cooperated" with it. He further accused the BJP of trying to divert people's attention from the Lalit Modi controversy. The BJP is losing ground both in Gujarat and at the Centre, he claimed, adding this was the reason for "sponsoring" the CBI raids on him as "political vendetta". "They have recovered nothing except a few old visiting cards and letterheads of the Textile Ministry," the former BJP-RSS strongman said.

The CBI has filed an FIR against Vaghela, former NTC chairman Ramachandran Pillai and other officials in connection with irregularities in land deals in Mumbai.

In a combative mood, Vaghela, who had a fallout with Modi and the Sangh Parivar in the late

1990s before joining the Congress, challenged the Centre to "prove me wrong".

"This is an attempt at character assassination at a time when the Congress is doing well for the upcoming local bodies elections in Gujarat," he said outside his bungalow after the CBI completed the raids.

Political reasons

"The BJP has realised that the Congress is set for a return to power in Gujarat in 2017 and they will be kicked out of their home. The "masters" of CBI were directing the officials. Somebody was monitoring the raids with constant calls to the CBI officials. This has become the BJP Bureau of Investigation," he alleged.

NTC was faced with losses of ₹1,800 crore, and it was during his tenure as Union Textiles Minister that the government was able to sell the company's defunct mills and recover as muchas ₹2,000 crore, he said.

The Congress high-command has expressed its support, he said, adding: "We will now explore our legal options."



No matter what the impact of technology and modern fads, our cultural heritage will always ignite a sense of pride in us, for our country and its heritage.

One experiences similar pride when one visits small haats in a city bursting with malls and shopping complexes. Somewhere, deep down they make a deep connect with us with their quaint, earthy and wholesome character, as opposed to their more plush and glitzy counterparts with their expensive fare.

A visit to a *haat*, which resembles a lot like rural India (long lost and forgotten by ur-

way to spend a weekend. But it's not just about *haats*. Even as we in India, and indeed around the world, gear up to celebrate World Ethnic Day on June 19, the moot question remains – 'how much ethnicity is really alive today?'

One immediately goes back to places like Hauz Khas Village (HKV) in the city, with an exclusive vintage feel of rural India. A hub of fashion designer stores and cafes, the place attracts a lot of youth and tourists, foreignere and from within the country, who list it as their all-time favourite hangout spot.

Similarly, there are three Dilli Haats running in the city, though the Pitampura and Janakpuri *haats* are comparatively less popular than the one in INA.

While the Pitampura Dilli Haat faces problems like lack of sufficient products, unreasonably high-priced items, unappealing variety and quality are operational, the one in Janakpuri is still relatively new and will take at least four years to get established, according to the authorities.

To learn more about the popular and successful one, Metrolife headed to INA Market, and was suitably rewarded. Known as the first-ever food, craft, culture and ecofriendly project, Dilli Haat provides the ambience of a traditional village market, but one suited for more contemporary needs. Here one sees a synthesis of crafts, food and cultural activity. It also provides the much needed platform for artisans, craftsmen and the hard working weavers, many of who are feted master craftsmen, from across the country

While speaking to Dilli Haat authorities at INA (who requested anonymity), *Metrolife* discovered some littleknown facts about this sprawling cultural spot of the city.

"When it comes to exclusivity and the stand-alone qualities of the *haat*, we can confithat are found here, cannot be found anywhere else in Delhi," say the officials.

Undoubtedly, the Punjabi *jooti*, the *zari dupattas*, the wooden toys and the ethnic *chadars* are difficult to find in the glittering malls and shopping complexes.

"It's not just about the shopping items...," they continue, "...the *haat* provides an effective and impressive platform to all our artisans and craftsmen, who work day and night to produce these wearable and decorative items. When people come and visit the craftsmen and the weavers and pay according to their hard work, that's when our mission is fully accomplished!"

Meanwhile, various cultural festivals and events regularly take place at Dilli Haat, which on the other hand are celebrated in a more ostentatious manner by some of the more popular malls, like Select Citywalk, in the city. Apart from the regular national festivals like Diwali Holi Fid and



home to various other fascinating events like the recently concluded Sharbat Mela, the Mango Festival, crafts mela while doubling up as a popular locale for film shooting, music and other cultural events.

While employment generation is one of the big affirmations of having a *haat* in the city, it also helps promote tourism to a large extent.

But there is flip side to this pretty picture. Where on one hand the 201 stalls from 25 states of the country provide employment and visibility opportunities to a lot of people, a lot of artisans are unhappy at not getting enough opportunities to showcase their creations at the stalls.

Lajwanti, a national awardee, sadly says, "Hamare koj ache din nahi acye hajn."

CBI files case against Vaghela

UPA minister had allowed land deal at throwaway prices

NEW DELHI/ KOLKATA/ AHMEDABAD: The CBI filed a case against Congress leader Shankarsinh Vaghela on Wednesday for allowing sale of a prime property in Mumbai at "throwaway prices" during his tenure as the textiles minister in the UPA-I regime.

The sale of National Textile Corporation (NTC) land in central Mumbai's Parel area to a private firm reportedly caused a loss of Rs 709 crore to the exchequer. Vaghela, former Gujarat CM and present leader of the Opposition in the Assembly, walked over to the Congress from the BJP in the mid-90's following differences with Prime Minister Narendra Modi. Vaghela had a running feud with Modi during his stint in Gujarat, and is named along with five others, including former NTC chairman and managing direction Ramachandran Pillai, in the FIR.

Two NTC officials–R K Sharma, then director (technical), and M K Khare, then senior manager (legal)–and Kamlesh Mehta of Kolkata-based Gowani Builders, then director of Hall & Anderson Ltd, were among others who were named in the case. Hall & Anderson Ltd is now known as Shree Madhusudan Mils Ltd. The FIR is the result of preliminary enquiry that went on for more than a year.

Sources said Vaghela entered into a conspiracy that al-

lowed Mehta to develop 27,500 square meters of the 80,785 square meter plot.

The mill, which was privately owned, was declared a sick unit and nationalised under the Sick Textile Undertaking (Nationalisation) Act, 1974. "The accused entered into a criminal conspiracy and transferred the land at Mumbai owned by NTC to a Kolkata-based private firm in a wrongful manner for a total consideration of (around) Rs 29.35 crore, whereas the actual value of the land was much higher. An alleged loss of (around) Rs 709.27 crore was caused to the government exchequer," a CBI statement said. » Vaghela, Page 8

Sources said Vaghela overruled the recommendation made by officials that NTC must give a detailed plan on the evaluation of the land before giving sanction for sale.

Vaghela termed the CBI move as "vendetta" politics. "It has been seven years of UPA-I. Why the inquiry was not initiated in these seven to 10 years (the sale of land took place in 2007-08). This is nothing but vendetta politics," he said.

He went on to claim that as per the information at his disposal, the Vajpayee-led NDA government was planning to sell all NTC lands in Mumbai for Rs 200 crore. "NTC had a debt of Rs 1,800 crore but due to the efforts of the previous government, it earned Rs 2,000 crore through NTC land deals."

The investigators also searched nine locations in four cities-New Delhi, Gandhinagar, Mumbai and Kolkatasoon after registering the case. Vaghela's residence was also searched.

The accused have been charged under sections 120-B (criminal conspiracy) and 420 (cheating) of the IPC and relevant sections of Prevention of Corruption Act, 1988.

The search operation began early morning at Vaghela's residence in Gandinagar and continued till about 4.30-5.00 pm.

CBI charges Vaghela for loss to NTC in land scam

AGE CORRESPONDENT NEW DELHI, JUNE 17

The CBI on Wednesday registered a case against former Union textiles minister Shankarsinh Vaghela, now Leader of the Opposition in Gujarat, and five others for selling over 27,000 sq.m. of prime National Textile Corporation property in Mumbai to a private firm at "throwaway prices", causing a loss of over ₹700 crores to the exchequer.

The agency filed an FIR under IPC sections on criminal conspiracy and cheating and provisions of the Prevention of Corruption Act on criminal misconduct, CBI sources said. It also conducted searches at nine locations, including Mr Vaghela's Gandhinagar residence, and the houses and offices of others involved in the case in New Delhi, Mumbai and Kolkata.

The case is over the sale of NTC property in the posh Worli area of Mumbai to a Kolkata firm for a meagre ₹29.35 crores. CBI sources said the FIR was filed after a year-long preliminary enquiry into the matter.

Besides the former Gujarat chief minister, those named in the FIR include then NTC chairman-cum-MD K. Ramachandran Pillai, its then director (technical) R.K. Sharma, senior manager (legal) M.K. Khare and a Kolkata private firm and its director, the sources said.

NTCLAND DEAL CBI books Vaghela for irregularities

EXPRESS NEWS SERVICE NEW DELHI, AHMEDABAD, JUNE 17

THE CBI Wednesday registered an FIR against former Union textile minister Shankarsinh Vaghela, former National Textiles Corporation (NTC) chairman and managing director K Ramchandran Pillai and others in connection with the irregular transfer of prime mill land in Mumbai to a private developer that allegedly led to a loss of around Rs 709.27 crore to NTC.

Others named in the FIR are R K Sharma, then Director (Technical) of NTC; M K Khare, then Senior Manager (Legal) of NTC; M/s Hall and Anderson Ltd; Kamlesh Mehta, Director of Hall and Anderson Ltd and other unknown persons. The accused have been booked under the IPC sections for criminal conspiracy and cheating and sections of the Prevention of Corruption Act.

According to CBI sources, cash worth Rs 13.33 lakh was seized during the search at the Gandhinagar residence of Vaghela, who said the move to file an FIR against him was like *"ulta chor kotwal ko dannte* (the pot calling the kettle black)" and an attempt to divert attention from the controversy surrounding External Affairs Minister Sushma Swaraj and Rajasthan Chief Minister Vasundhara Raje.

The sources also said a fixed deposit of Rs 1.65 crore and a locker were seized during a search at Pillai's residence, two lockers and credit cards were seized from Sharma's home and a fixed deposit of Rs 45 lakh and a locker were seized at Khare's . residence.

Searches were also conducted at the offices of NTC in New Delhi and Mumbai, the office of Hall and Anderson in Kolkata and at the office of a firm called Lotus Enterprises in Mumbai.

"The accused entered into a criminal conspiracy and transferred the land of M/s Shree Madhusudan Mills in Worli, owned by the NTC since the mill was nationalised, to Mehta's firm in Kolkata in July 2009 in a wrongful manner for a total consideration of Rs 29.35 crore whereas the actual value of the land was much higher. This led to an alleged loss of Rs 709.27 crore to the government exchequer," said a CBI source.

Sources further said that Hall and Anderson was allowed to develop 27,500 sq m of the 80,785 sq m mill.

According to the CBI, M/s Shree Madhusudan Mills was, taken over by the Ministry of Textiles/NTC and nationalised under the Textiles Undertakings (Taking over of Management) Act, 1983 and the Textiles Undertakings (Nationalisation) Act, 1995.

"All assets of the said firm were transferred to NTC and a suitable amount was paid as compensation to M/s Shree Madhusudan Mills," said a CBI source.

Elaborating on Vaghela's role, the source said, "It is alleged that in the process of settling of issues regarding taking over of assets and liabilities of the said firm, the then Union Minister of Textiles overruled the opinion of senior officers of the ministry for a comprehensive proposal from NTC, which owned the land, including recommendation by the officers for actual valuation of the land for settlement of the issues."

The source added: "Abusing his official position, the textile minister approved the sharing of the land in the ratio of 65 : 35 in the favour of Hall and Anderson Ltd, owned and controlled by Kamlesh Mehta. Accordingly, 35 per cent share of land was transferred to Hall and Anderson Ltd against consideration of Rs 29.35 crore," the source added.

The CBI had registered a Preliminary Enquiry in the matter on May 13, 2014.
